09/02/2016	Case Review Court has reviewed the pleadings filed by the parties regarding Respondent's motion for new trial and other post trial motions. Court denies Respondent's motion for new trial and motion to reopen evidence and motion for relief from judgment. Court notes that this case was continued from the 12-18-15 hearing date due to Respondent's changes in values of the marital property on her form 2 on the eve of trial. Respondent was given the opportunity to amend her Form 2 and the court considered the Respondent's amended values in the subsequent trial. Court did not accept the valuation of the contents of the condo in New Jersey due to the sparseness of the items listed and the court did not feel that a complete disclosure of the household goods was listed. Court does grant Respondent's request to recalculate the award of monies owed to her as her share of the marital assets. Court's calculation of 4-4-16 was in error and Husband owes to Wife the sum of 89,661.50 instead of 78,000.00. Court notes that the post trial motions and responses were well plead and argued and the court is very appreciative of the Attorney's good work. Petitioner's request for attorney's fees is denied.
