## John's List of NJ Apartment Contents

My sister lived in apartment full time for about 3 years and furnished most of apartment. I eventually did replace some furniture over time and that furniture which belonged to me was in the appraisal

Many items John listed in apartment did not belong to me. It was a leased apartment. Kitchen lights and appliances were part of apartment and could not be removed.

Items he listed that actually belonged to me are extremely overinflated. Items belonging to me were appraised and appraisal is in next document. Also note all items John listed such as appliances, he chose not to list in the home we shared.

Many items John listed just plain did not exist.

If you add the total of the items John listed, including things I did not own or that did not exist, His total comes to \$10,100.

The appraisal of apartment contents belonging to me \$1,345.

John and attorneys claimed the value of apartment contents \$26,345.

65. \$45 Clocks. One clock in Kitchen. Cost \$10 from Dollar Store.
66. \$350 Dining Room Set. There is a small table and chairs in apartment. In appraisal
67. \$125 Chandelier. There is an original kitchen light over table. It is probably original equipment from when apartment was built in the 1980's. Apartment is leased and it belongs to apartment. Can repair or replace but not remove
68. \$250 Refrigerator. Was in apartment when I leased it, cannot remove
69. \$35 Canister Set. If there was a canister set it would have belonged to my sister
70. \$100 Had a small sweeper when I leased apartment. It expired within first year and used swifter when I was there. If there was a vacuum it would have belonged to my sister
71. \$100 Carpet shampoo/cleaner. Did not exist
72. \$200 Washer/Dryer. Belonged to apartment as part of lease
73. \$15 Ironing Board. No value. Belonged to my sister
